Official Rules

THE SWEEPSTAKES IS SUBJECT TO ALL APPLICABLE FEDERAL, STATE, PROVINCIAL, TERRITORIAL, MUNICIPAL/LOCAL LAWS. VOID WHERE PROHIBITED. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE ENTRANT’S CHANCE OF WINNING.

1. Sponsor/Administrator (UNITED STATES): For entrants from the United States, The Sweepstakes is offered and sponsored by Chevron Products Company (a division of Chevron U.S.A. Inc.) (the “U.S. Sponsor”) and administered by Unified Resources, Inc. (the “U.S. Administrator”). The U.S. Sponsor is located at 6001 Bollinger Canyon Road, San Ramon, California 94583. The U.S. Administrator is located at 10665 Richmond Ave. Suite 130, Houston, Texas 77042.

Sponsor/Administrator (CANADA): For entrants from Canada, the Sweepstakes is offered and sponsored by Chevron Canada Limited (the “Canadian Sponsor”) and administered by Marcom Group - (the “Canadian Administrator”). The Sweepstakes is co-sponsored by the U.S. Sponsor and Canadian Sponsor (collectively the “Sponsors”) and co-administered by the U.S. Administrator and Canadian Administrator (collectively the “Administrators”). All entrants agree and understand that they are providing their information to the Sponsors. 2. Eligibility: The Sweepstakes is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least eighteen (18) years old at the time of entry as well as legal residents of Canada (including Quebec), who are at least nineteen (19) years old at the time of entry. Computer

For Canada: During the Sweepstakes Period, entrants may enter the Sweepstakes by registering online at sweeps.havolinepromotions.com and clicking on the Canadian entry process. Follow the on-screen instructions and complete the registration form by providing all of the information requested. The first landing page will include a separate consent feature tab to opt in to receive text messages and information on how to opt in to Sponsor's promotion. When the form is complete, click the "Submit" button to receive one (1) entry into the Sweepstakes. No purchase is necessary to enter or win. The Sweepstakes registration form shall include a separate tab to opt in to the Text Coupon Promotion ("Promotion") to receive Havoline oil change coupons and marketing information from the Sponsor. Opting in to the Promotion is optional and NOT required to be eligible to enter the Sweepstakes or to win a prize. 5. Limits/General Provisions: All potential winners are subject to verification before any prize will be awarded.

Limit: **Each entrant may receive one (1) entry during the Sweepstakes Period.** Limit one prize per person/phone number. Multiple entrants are not permitted to share the same phone number. On or around November 2, 2018 at approximately 2:00 p.m. CST the Administrator in Houston, TX U.S.A. will draw ten (10) entries from all US entries received August 1 – October 31, 2018.

On or around November 2, 2018 at approximately 2:00 p.m. CST the Administrator in Houston, TX U.S.A. will draw one (1) entry from all Canadian entries received August 1 – October 31, 2018.

In all, thirty (30) US prize winners will be drawn during this Sweepstakes.

In all, three (3) Canadian prize winners will be drawn during this Sweepstakes.

In all, thirty three (33) prize winners will be drawn during this Sweepstakes.

All entries become the sole property of the Sponsors and none will be returned. If, for any reason, the Sweepstakes cannot be run as planned, including due to tampering, unauthorized intervention, fraud, technical failure, human error or any other causes beyond the control of the Sponsors that corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes, the Sponsors reserve the right in their sole discretion, to disqualify any person who tampers with the entry process, and (in Quebec, with the permission of the Régie des alcools, des courses et des jeux in Quebec) to cancel, terminate, modify or suspend the Sweepstakes and if the Sponsors do so, to conduct some or all prize drawings from among all valid entries received to that point during the Sweepstakes Period through all methods of entering to the date of termination. How to Opt-Out. To stop receiving text messages from a specific Sponsors and Administrators text messaging program, text "QUIT", "END", "CANCEL", "UNSUBSCRIBE", or "STOP ALL" to 55678 in the US or 70734 in Canada. Entrants will then receive confirmation of entrants opt-out of the text messaging program.

Termination of Text Messaging: Sponsors and Administrators and or Administrator may suspend or terminate entrants receipt of Sponsors and Administrators text messages if Sponsors and Administrators, iVision, and its

Administrator believes entrants are in breach of these Official Rules. Entrants receipt of Sponsors and Administrators text messages is also subject to termination in the event entrants mobile telephone service terminates or lapses. Sponsors and Administrators reserves the right to modify or discontinue, temporarily or permanently, all or any part of Sponsors and Administrators text messages, with or without notice.

7. Verification of Potential Sweepstakes Winners: Receiving a prize is contingent upon compliance with these Official Rules. The potential winners will be **notified by phone number supplied at time of entry**. Average annual cost of annual oil changes: \$110.00 - \$150.00 USD
